

20% premium surimi (Nemipterus Japonicus (**fish**), water, tapioca starch, **egg white powder**, **soybean oil**, crab flavour (**crustaceans**), sugar, salt, colourant (E160c)),

15% cooked cat tiger shirmps (Parapenaeopsis Hardwickii (crustaceans), salt, stabilizer (E451, E452)).
